Subject: Minutes of the review meeting of District Bandipora by Div. Com, Kmr.

A meeting to review the decisions/directions/instructions given by the Hon'ble Chief Minister during the Public Darbar held by her at District Bandipora on 03.12.2017 was held under the Chairmanship of Mr. Baseer Ahmad Khan, IAS, Divisional Commissioner, Kashmir on 28.12.2017 at District Dev. Commissioner's Office, Bandipora in which Deputy Commissioner/Heads of Department and other District Level Officers were present.

Pertinent to mention here that decisions/instructions, aggregating 316, were given by the Hon'ble Chief Minister in the Public Darbar held at District Bandipora and fixed timelines, against each, for their implementation as indicated in the Annexure A & B, out of which 20 decisions are implemented. It was impressed upon the Officers that in case of any laxity/default in achieving the results within the timeline, he/she shall be held personally responsible. Besides, Deputy Commissioner, Bandipora was directed to constitute various Monitoring Committees to inspect the works and ensure the proper execution of works as per estimates and standard norms supported by pre-execution and post execution photographs. These instructions were also endorsed by this office vide letter No. DivCom/Dev/2018/Budgam/2017/7714-25 dated 09.12.2017.

It was also conveyed to the Officers that periodical review to ascertain the status of the implementation of directions/decision/instructions shall be conducted on monthly basis.
