ORDER

Whereas, a final seniority list of Patwaris of District Bandipora was issued / circulated vide this office order No:- DCB/Estt/2016/625-37 Dated: 02.11.2016 in light of the instructions of Hon'ble High Court passed in SWP No. 2275/215 clubbed on 30.05.2016;

Whereas, some patwaries under district cadre Bandipora have been promoted as Girdawar's vide order No. 247 DIVK-E-2015 Dt: 29.10.2015 and vide No. 694 DIVK-E-2016 Dt: 07.12.2016;

Whereas, one Peerzada Altaf Ahmad Shah and others have filed a writ petition No. CAPASW No. 199/2016 CMP No. 01/2016 C/W LPASW No. 206/2016 MP No. 01/2016 before the Hon'ble High Court against the said seniority list of the Patwaris and accordingly the Hon'ble High Court has disposed off the writ petition on 26.09.2017 with the following directions:-

13. "in the result, the decision of the learned single Judge which is impugned before us has to be set a side and the appeals have to be allowed. This is so because seniority is to be determined in terms of Rule 24 of the 1956 Rules notwithstanding any delay on the completion of the probation period. Therefore, the seniority as determined on the date of first appointment by the Revenue Department on the basis of merit of the select list prepared by the Service Selection board shall prevail. The consequences of this would be that SWP No. 1762/2015 and SWP 2275/2015 shall stand dismissed. The appeals shall stand allowed and the position of the seniority list shall be the same as was obtaining prior to filing of the writ petition"

Whereas, in perusance of the above directions of the Hon'ble High Court and as per the instructions of the Divisional Commissioner Kashmir given vide No. DivCom /33-PTW/Estt dated: 26.10.2017, a tentative seniority list as on 01.03.2018 of the patwaries of District cadre Bandipora working in this district and outside district under the control of Irrigation & Flood Control and Regional Director Land Survey and records Kamraz Baramulla has been framed.

Now therefore, in view of the above, a tentative seniority list as on 01.03.2018 of the patwaries of District cadre Bandipora working in this District and outside District under the control of Irrigation & Flood Control and Regional Director Land Survey and records Kamraz Baramulla has been framed **and is available on our District Website www.bandipore.gov.in** for filling of objections. The objections if any from any Patwari shall be submitted to this office within 07 days from the date of publication of this order in the daily Newspapers, thereafter, no objection will be entertained.
